With the Arp Fire Department. Addressed audience with support and encouraged any questions anyone had. Mr. Arnold informed Arp Fire Department is attempting to assist in lowering and addressing the upcoming Home Owners Insurance rate increase approved by the State Insurance Board. They were able to help in the City of Arp but is still a work in progress in the rural areas.

Mr. Davis relates there are 1170 miles of roads the county maintains. A study has been in progress and should be ready to present to the County Commissioners in late June or early July for Capital improvement projects. Currently have 3 million dollars for Capital improvements, gave example of 1 mile of overlay cost \$120,000.00 therefore 3 million will be hard pressed to cover 1170 miles of roads.

Mr. Nix stated his idea for road improvements is to take it to the people of the county in a vote for a 2-3 cent tax increase for Capital improvements.

Question from the audience: What about the large trucks coming and going so much out here in the community, oil trucks, supply trucks and cement trucks. Are these companies held accountable for overload and tearing up the roads? Mr. Davis reply was it was something that could be looked into but is usually after a project is completed and then evaluate the road for damages.

- Question from the audience: Speeding is a big problem in the community. Mr. Davis reply a look at the signage can be evaluated, is there enough signs. Mr. Nix will also speak to the Constable for additional patrol in the community.
- Question from the audience: What about putting a street light at the entrance? Mr. Davis reply that is up to the Electric Company. Board member states lights like a solar have been stolen in the past and Cherokee County Electric Coop says there is no service to this area to pull from.
- Question from audience: Who can we call or comment about our roads etc. Mr. Nix provided Road and Bridge 903-590-4801, try to be specific about the problem even an address if available. Every week there is an opportunity to speak to the Smith County Commission, the public form is prior to the meeting and you have 3 minutes to speak.
- Question from the audience: Concern about the amount of garbage along our roads. Mr. Nix will check on the possibility of Trustee's from the county jail picking up trash along road ways.
- Questions from the audience: What about some of the trees along Old Whitehouse road that have been damaged by the drought and now the rain. Both Mr. Nix and Mr. Davis state is a case by case and most recently have been very busy with all the storms taking care of the emergency situations.
- Question from audience: is hunting allow out in our community? Answer: this community is a preserve and no hunting is allowed.

Treasurer's Report – presented by Steve Hall; hand out with outline available for review. Explained have not had large projects this past year, saving for proposed projects for upcoming year. Approved by audience unanimous sign. Out lined proposed projects:

- Placing fence all the way to the water at Boat Ramp #1; to prevent driving around to access the boat ramp.
- Repair or replace security light at the Helo port at Pavilion
- Replace gate at Pavilion
