



All that certain tract lot or parcel of land Smith County, Texas, and also being a part of a tract of land described in a Trustee's Development Company to Henry M. ... 1480 Page 696 of the Deed Records completely described as follows to wit:

Beginning at a 1/2 inch iron rod found Resources II LP called 0.425 acre tract in the S.E.B.L. of the A.R. Real Estate Page 143);

Thence North 64 degrees 13 minutes said 5.077 acres, for a distance of 205.36'

Thence North 63 degrees 59 minutes line, for a distance of 93.09 feet, to a 1/2" R.O.W. line of Fisherman's Drive;

Thence South 66 degrees 01 minutes R.O.W. line, for a distance of 80.58 feet, curve to the right;

Thence continuing along said Southern which has a Central Angle of 15 degrees 714.55 feet, and a Chord Bearing of East, for a distance of 198.06 feet;

Thence South 50 degrees 04 minutes R.O.W. line, for a distance of 85.00 feet, P.C. of a curve to the left;

Thence continuing along said R.O.W. line a Central Angle of 14 degrees 40 minutes and a Chord Bearing of South 57 degrees distance of 23.00 feet to a 1/2 inch iron rod Bay Land Corporation called 24.348 acres;

Thence South 05 degrees 41 minutes said 24.348 acres, for a distance of 24.348 feet at the S.W.C. of said 24.348 acre tract Moseley called 12.935 acre tract (Volume 3123 Page 452);

Thence North 80 degrees 42 minutes said 12.935 acres and along the S.E.C. of said tract (Volume 7815 - Page 439); found for corner at the S.E.C. of said tract;

Thence North 64 degrees 13 minutes said 0.425 acres, for a distance of 205.36 feet at the East corner of said 0.425 acre tract;

Thence North 25 degrees 55 minutes said 0.425 acres, for a distance of 205.36 feet at the East corner of said 0.425 acre tract;
